#### **GENERAL FUND**

**REVENUES:** December operating revenues totaled \$1,496,201 compared to \$1,647,985 for the same period last year. YTD operating revenue is 3% above budget. December sales tax collections totaled \$955,893, compared to same period last year \$1,055,997. Franchise fees and permit revenues totaled \$83,175.

**EXPENDITURES:** December expenditures totaled \$2,003,372 comprised of Personnel Related Expense of \$1,590,381 which included three pay periods and an Employee Stipend from Appropriations 22-2070 and 22-2071. Utilities & Other Expense were \$412,991. Expenditures were 4.3% below year-to-date projections.

#### STREET FUND

**REVENUES:** December Street revenues totaled \$1,037,473; 2021 Sales Tax \$610,794, State Turnback and Advalorem Tax \$189,914, State ½ Cent Road Tax revenue \$67,279, Interest \$116,176, Transfer from General Fund \$30,743 (Stipend), General Fund Reimbursement \$15,000 (RPD Vehicle Maintenance), RSD Reimbursement of Crossing Light Installation \$6,599, Utility Reimbursement \$668, and Street Cutting Permits \$300. Street Operating Revenues were 19.5% above budget.

**EXPENDITURES:** Operational expenditures for December were \$236,588 comprised of Personnel Related Expense of \$193,087 (Three pay periods and a Stipend) and Utilities & Other \$43,501; Street Capital spending was \$263,237 for a Ventrax Mower and a Wheel Excavator; ½ Cent Sales Tax Spending was \$187,376 for Schoolhouse Trail; Sales Tax Spending was \$571,098; Payment Preservation \$474,409; Sidewalk Maintenance Phase 2 \$46,162; 8th Street Sidewalks \$26,690 and East Circle Drive Drainage Maintenance \$23,837.

## **ECONOMIC DEVELOPMENT FUNDS**

**REVENUES:** December revenues totaled \$844,667; Sale of Farm Acreage \$739,996; New sales tax revenue of \$87,256 and \$17,415 in Interest.

**EXPENDITURES:** December expenditures were \$372,721; Final on the City Park Splash Pad \$345,124; Reimbursement for AR Valley Alliance 5,535 and \$22,062 Reimbursement for Workforce Development Services.

#### CAPITAL ASSET FUND

REVENUES: Total revenues for December were \$1,850 in Interest.

**EXPENDITURES:** Capital Asset expenditures for December totaled \$57,600. Purchase a replacement vehicle for RPD \$34,248; Purchase of Infrastructure, a 12 port switch for \$11,772; Hickey Pool Renovation \$5,355 and \$3,225 for Engineering on the Hanger Door Replacement Project at the Airport.
