The Hughes Community Center is an equal access facility. Its recreational purpose is to serve the whole community with an environment for all ages. The following rules and regulations have been established to ensure the facility is used in the intent for which it was built. The department reserves the right to deny access to those persons who may be a danger to themselves or others and to anyone who does not adhere to the following rules:

## **RULES AND REGULATIONS**

1. **Full court basketball is not allowed unless scheduled through the office.**
2. **No cursing, fighting, or unruly behavior on premises.**
3. **Participants must be appropriately dressed for any activities. Clean clothes and shoes must be worn in the weight room. Shirts and shoes are required at all times and only tennis shoes are allowed while playing on the court.**
4. **No animals allowed inside the building with the exception of animals aiding the handicapped.**
5. **Persons found possessing weapons, illegal drugs, or conducting themselves in an inappropriate manner will be permanently denied access to this facility.**
6. **Abuse of facilities (this includes the floor) or equipment will not be tolerated.**
7. **Absolutely NO SPITTING.**
8. **Loitering, which creates excessive noise and/or disturbances, will not be tolerated.**
9. **Food and drinks are to be consumed in designated areas only.**
10. **No smoking, drugs, or alcohol on premises.**
11. **Sports equipment is to be used in gymnasium only (no bouncing balls in lobby).**
12. **You must have a weight room membership to use the weight room. You must be 14 years of age or older to have a membership.**
13. **An underage waiver must accompany membership forms for anyone under the age of eighteen.**
14. **Weight room members may not have a guest at any time in the weight room.**
15. **Gym bags are not allowed in the weight room.**

**Violation of these rules may result in suspension of privileges.**

All activities at the Hughes Community Center are monitored.  
Rules and regulations will be strictly enforced.

Fees for weight room are \$15.00 per month.

1. Members must register in the office before entering the weight room and must sign out upon exiting the weight room.
2. A list of current members is kept in the office. It is the member's responsibility to keep his/her membership current.
3. Use of weight room requires a person be 18 or older unless their membership form is accompanied by an underage waiver.
4. Non-members will not be allowed in the weight room. Children will not be allowed to accompany their parents into the weight room.
5. The Hughes Center does NOT provide supervision for children. We do try to provide every caution to promote safety.
6. Hughes Center rules and regulations are posted and must be followed at all times.
7. Weight room rules are posted and must be followed at all times.
8. Disregard of rules and regulations of the Hughes Center and/or weight room may result in termination of membership, and future use of facilities.
